Admission 2026-27

Admissions to various programmes of the College shall be carried out in a transparent and merit- based manner according to the Government and University norms.

Application Procedure

The College will issue a notification inviting applications for admission to various programmes. The notification will be published through the official website and other appropriate communication channels.

All admission notifications are issued only by MES College Marampally (Autonomous). **The College does not conduct admissions through the MG University CAP Portal.** Applicants are advised to refer exclusively to the official communication channels of the College for updates regarding application submission, rank list publication, allotment, and admission procedures.

Submission of Applications

Candidates shall submit their applications online within the stipulated time period mentioned in the notification. Applications received after the closing date will not be considered.

Application Fee

All candidates are required to remit the prescribed application fee at the time of submitting the online application. The application process will be considered complete only after successful payment of the application fee. Applications submitted without payment will be treated as incomplete and will not be considered for admission.

Management Quota Admissions

Candidates seeking admission under the Management Quota are required to contact the College office directly for further details regarding application process, and admission formalities.

Preparation and Publication of Rank List

After the closing date of applications, the College will prepare a Rank List based on the Index Mark calculated according to the norms prescribed for each programme.

The published Rank List will include

- Sure List – Candidates who are provisionally selected for admission.
- Waiting List – Candidates who may be considered for admission against vacancies arising later.

Reservation Policy

Reservation of seats under all applicable categories shall be strictly implemented in accordance

with the norms and regulations prescribed by the Government of Kerala and Mahatma Gandhi University, Kottayam

The Rank List will be published on the official website of the College. Candidates can view the same through their individual login.

Allotment Memo

Candidates included in the Sure List can download the Allotment Memo from their individual login.

Allotment Fee

Candidates who receive allotment must remit the prescribed allotment fee within the stipulated time. The allotment shall be confirmed only upon successful payment of the allotment fee.

Failure to remit the fee within the specified period will result in automatic cancellation of the allotment, and the seat will be offered to the next eligible candidate as per the rank list.

Admission Procedure

Candidates must report to the College on the specified date with the required documents and fee receipt for completing the admission process.

- Candidates who receive admission to their first option programme must take Permanent Admission.
- Candidates who are allotted programmes other than their first option may choose to take Temporary Admission, subject to the rules and conditions of the college.

Failure to report for admission within the stipulated time will result in forfeiture of the allotment, and the seat will be offered to the next eligible candidate from the Waiting List.
